Improvements and Continuity

The Annual Report of the National Foundation for 2017 presents a year which has brought about changes in the work of the National Foundation for Civil Society Development given that, after a year of standstill, the Management Board of the National Foundation was appointed by the Decision of the Government of the Republic of Croatia on 8 June 2017.

The Management Board faced a great challenge of harmonising much needed continuity of the National Foundation's activities with expectations regarding improvements in the area of grant giving. This was achieved by the adoption of the National Foundation's Strategic Action Plan for the period 2017-2021, which provided for continuity of grants awarded by the National Foundation over the last 14 years, as well as improvement in terms of introducing initial programme cooperation in the areas which are essential for social development in the Republic of Croatia.

In 2017, the Annual Report of the National Foundation for Civil Society Development makes a step forward in the manner and form of presenting various activities and valuable results achieved in the previous year in the area of providing support to civil society development in the Republic of Croatia.

The year 2017 was marked by celebrating the 14th anniversary of the National Foundation's activity, when all results were put together, challenges and the responses to them were analysed, but also joyful moments when we and our partners from CSOs, state administration bodies, and local and regional self-government units were satisfied with our contribution, no matter how small, which made an impact on social changes and the development of civil society in our country.

We are particularly proud of the continuity of grant giving, where new specialised calls were introduced for CSOs of persons with disabilities and CSOs from the Homeland War active on the local level, as well as a special call for institutional grants for the CSOs which were not the beneficiaries of this type of grants in the previous periods, which led to a multiple increase in the number of institutional grants. We also express our satisfaction with successfully conducted activities of the National Foundation as Intermediate Body Level 2 within the ESF Operational Programme Efficient Human Resources with regard to the implemented calls and contracted projects for ESF grant funding.

As Intermediate Body Level 2, the National Foundation for Civil Society Development lays great importance on professional and efficient performance of the tasks entrusted within the Operational Programme Efficient Human Resources, whereby it places a particular emphasis on the work and communication with the beneficiaries of ESF grants as important factors of efficient and timely utilisation of the resources available to the Republic of Croatia within this programme.

The biggest step forward in 2017 was the Decision of the National Foundation's Management Board of 2 September 2017, which marked the beginning of the process of establishing the National Foundation's regional branches in Osijek, Rijeka and Split.

Regional branches are a constituent part of the Department for Support and Monitoring of the Implementation of EU Programmes at the National Foundation and will provide support to the beneficiaries of approved grants from the ESF at the local and regional level in order to enhance the level of professionalism and effectiveness connected with the implementation of project activities focusing on end-beneficiaries, the quality of approved funds utilisation and the impact on social (and economic) development in the Republic of Croatia.

The Civil Society Regional Development Programme has been continued and will, together with the regional branches, create a synergy of support and training both for applicants to ESF calls and for beneficiaries. In local communities, activities are modified through cooperation with partner foundations involved in the programme "Active in the Community", while development cooperation in the area of the Centres of Knowledge for Social Development in the Republic of Croatia has expanded to include the 9th Centre of Knowledge, which consists of 15 umbrella CSOs from the Homeland War. Furthermore, development cooperation in the area of philanthropy and foundations, as well as support to the Croatian Foundations Forum "ZaDobro.BIT!", is further continued.

With all of the challenges and new opportunities, the year 2017 was also a year of measurable indicators of changes and impact which we had achieved through investment in 377 grants offered to CSOs, which provided employment for 732 persons in total, as well as around 15,600 volunteers with approximately 590,000 volunteering hours with multiple impact on the improvement of Croatian citizens' quality of life, increase in the level of social capital, promotion and protection of human rights, environment conservation, sustainable development, social inclusion of excluded groups in various ways, establishment of the society's democratic institutions, development of social entrepreneurship, reduction of poverty and reaffirmation of values such as empathy and solidarity among people.

I believe that, in reading our Annual Report of the National Foundation for 2017 which is before you, you will obtain all the necessary information on grants provided by the National Foundation in the area of civil society development in the Republic of Croatia, as well as the results of it.

The Year of New Possibilities

The year 2017 saw the initiation of the new, 4th term of the National Foundation for Civil Society Development's Management Board (2017-2021), which was also a turning point towards a new environment for the National Foundation's activities, owing to the support and understanding of the Government of the Republic of Croatia with regard to the importance of an organised civil society's activities in our country.

Despite the challenges, many valuable projects and events were realised in 2017, which have enriched our society and offered help to those in need of it. Through quality management of its assets and support of CSOs, the Government of the Republic of Croatia, the Croatian Parliament, units of local and regional self-government, international partners, the media and citizens, the National Foundation has managed to carry out its mission, which is support to civil society development in our country.

Last year was also a year of new possibilities, given that the newly appointed Management Board recognised and supported initiatives related to changes in the National Foundation's internal structure in order to facilitate the implementation of two programme units of its activities, namely, national financing through development programmes and financing through programmes of the European Union. The establishment of regional branches in Osijek, Rijeka and Split, as well as the synergy of existing support programmes with new programming and financing possibilities, created the preconditions for systematic support to civil society development in the subsequent four-year period. In addition, we successfully carried out our role of Intermediate Body Level 2 in the Operational Structure on the level of the Republic of society as part of the Operational Programme Efficient Human Resources, and thus demonstrated well-known professionalism and efficiency of the National Foundation's previous work in that area through development programmes and national financing. The Programme for Civil Society, which the National Foundation successfully conducted as implementing body of the donors of the European Economic Area and Norway Grants, was finished in 2017, which is another confirmation of the recognition and quality of the National Foundation's activities in the international context.

A step towards new possibilities was also made with the decision on introducing the Initial Programme Cooperation in 7 new programme areas, including:

- STEM and CSOs
- STEM and local community development
- Human rights and globalisation
- · Youth employment through cross-sector cooperation
- Prevention and protection of health
- Modern addictions
- Euro-Mediterranean partnership

which encompass new challenges and needs of social development in Croatia.

We wish you pleasant reading of this Annual Report of the National Foundation for the previous year, in the hope that the period opening up for us with the use of EU structural funds will be a new opportunity to use all of the new possibilities provided by EU membership: from participation of our citizens in the processes of adopting public policies on the European level, to the financing of projects and programmes of importance to different areas of social and economic development of the Republic of Croatia.

About the National Foundation

The National Foundation for Civil Society Development was founded by the Republic of Croatia under *lex specialis*, the Act on the National Foundation for Civil Society Development, adopted by the Croatian Parliament on 16 October 2003, as a public foundation whose main purpose is to promote and support civil society development in the Republic of Croatia. The Foundation was registered on 24 November 2003 with the aim of providing professional and financial support to programmes promoting sustainability of the non-profit sector, cross-sector cooperation, civic initiatives, philanthropy and volunteering, and to programmes enhancing democratic institutions of the society.

According to the European and global classification, the National Foundation is a mixed public foundation engaging in grant-giving activities (Grant Giving Foundation), and, operationally, in other activities in cooperation with other organisations (Operative Foundation).

The National Foundation is the leading public institution for

cooperation, networking and financing of civil society organisations in the Republic of Croatia, which has held since 2006 the internationally recognised certificate HRN ISO9001:2008 for the management of the grant award system.

Through systematic investments in human potentials and developed internal communication, the National Foundation has built a competent team of creative, capable and motivated employees with whom it responsibly and transparently achieves the given objectives.

Adapting to the needs of development in Croatia and in Europe, the National Foundation conducts research and transfers the knowledge and information needed for the development of active citizenship and cross-sector cooperation. By sound management of the foundation's assets and revenue from public sources of the Republic of Croatia and the European Union, as well as other revenue, the National Foundation develops and finances programmes for social development and civil society development in the Republic of Croatia.

— Mission

The mission of the National Foundation is to promote and support civil society development in the Republic of Croatia.

— Vision

With its activities, the National Foundation endeavours to realise active citizenship in the development of a modern, democratic and inclusive society in the Republic of Croatia.

Objectives

- 1. Encouraging citizens to become active, get involved and take part in the development of the local community and society;
- 2. Building civil society's capacities for participation in social development;
- 3. Developing cooperation among CSOs and cross-sectorpartnerships;
- Increasing visibility of CSO activities and their public nfluence;
- 5. Supporting social innovations and employment in the non-profit sector.

In the third 4-year period of the National Foundation's operations (from 2012 to 2017), which was extended by a year of transitional period, the Croatian Government appointed members of the new, 4th term of the Management Board for the period from 2017 to 2021, which appointed the director of the National Foundation in July 2017, and in September 2017 adopted a new Strategic Action Plan for the period 2017-2021.

Achievements in 2017 and Socio-Economic Effects

— Achievements

- Fifteen CSOs from the Homeland War successfully ended the transitional period of Development Cooperation for their inclusion into the 9th Centre of Knowledge in the area of improvement of the quality of life of Croatian veterans and civilian victims of the Homeland War;
- For the first time a separate call for institutional grant awards was launched, intended for CSOs which had not received the mentioned form of the National Foundation's grants in the past periods;
- The European Day of Foundations and Donors, celebrated throughout Europe on 1 October, was marked for the second consecutive year in such a way that the National Foundation, together with the European Foundation for Philanthropy and Society Development and foundations involved in the Croatian Foundations Forum ZaDobroBit organised the Philanthropy Week 2017 from 25 September to 2 October in larger cities in Croatia, with the central event held at the People's Square in Zadar, as well as the Conference on Philanthropy and Foundations which was held on 2 October in IMPACT European Centre for Cross-Sector Partnerships, with the involvement of local and international philanthropy experts;
- In order to celebrate the ending of implementation of projects approved within the framework of EEA and Norway

For the fifth year, the National Foundation has been acting as Intermediate Body Level 2 in the management of EU funds

Grants, a closing event was organised, in which all achievements of the Programme were presented in an animated film and exhibition in the lobby of the Mimara Museum. The said event served as an announcement of the following financial period in the Republic of Croatia.

- In order to provide systematic support to all interested applicants to calls which will be published within the framework of the European Social Fund, the National Foundation has established the Department for Support and Monitoring of EU Programmes which will operate in Zagreb and three branches: Osijek, Rijeka and Split;
- The "ESF_Plus" platform for reporting was established, facilitating communication with beneficiaries regarding the projects approved in the programme period 2014-2020 and speeding up the process of submitting requests for payment, as well as its review and approval by the National Foundation.

— Effects

Volunteers and GDP

— In 2017, a total of about 15,600 volunteers were involved in 285 grants given by CSOs, with around 590,000 volunteering hours. If we were to put these volunteering hours into an economically measurable framework at the price of an average hourly rate in the Republic of Croatia, these volunteering hours would be worth HRK 26,550,000.00, which is a share of about 0.0073% in GDP.

Employees and payments to the state budget

— In 2017, 732 persons employed by CSOs received a salary through approved grants of the National Foundation, thus, through taxes on salaries of these persons, around HRK 11,500,000.00 was paid into the national budget.

Structure of employees

— Of a total of 1,334 employees in supported CSOs in 2017, the structure of employees was as follows:

other national grant givers: 148 (20%)

Sustainability

— In 2017, out of 151 CSOs which were beneficiaries of institutional grants, 71 (47%) of them did not have and 80 (53%) had*a developed form of self-financing related to generating revenue by performing activities, through

The collected data show that, in 2017, CSOs generated funds amounting to approximately **HRK 9,000,000.00** through the activities presented above.

Citizens' support

— In 2017, of 151 CSOs which were beneficiaries of institutional grants, 79 of them (52%) received citizens' donations amounting to approximately HRK 2,500,000.00

Cross-sector support

— In 2017, of 151 CSOs which were beneficiaries of institutional grants, 92 (61%) of them received donations from the profit sector amounting to approximately HRK 3,900,000.00

EU funds

— n 2017, of 151 CSOs which were beneficiaries of institutional grants, 45 (30%) of them did not apply to EU calls, while 106 (70%) of them applied to EU calls with around 300 projects, and about 140 projects co-financed by EU funds were implemented

Membership

— In 2017, of 151 CSOs which were beneficiaries of institutional grants, 93 (62%) of them increased and 58 (38%) did not increase the number of their members





Contribution of the National Foundation:

— To the improvement of beneficiaries' capacities through grant implementation monitoring

During the implementation of approved projects and multiannual institutional grants, the National Foundation conducts programme and financial evaluation of contracted grant implementation. Based on the results of the conducted evaluation, among other, bases are established for the extension or continuation of financing institutional grants in the following year.

The evaluations conducted demonstrated that the majority of CSOs had no difficulties in their work regarding the implementation of activities established by the strategic and operational plan, and the transparency of operations, including the financial part of the implementation of approved grants.

In addition to the regular evaluations, in 2017 the National Foundation also conducted 88 programme and financial preevaluations in CSOs which through their activities contribute to democratisation and social development, and which were shortlisted for the approval of institutional grants in four calls published in 2017.

In order to familiarise beneficiaries of the approved institutional grants with the method of grant implementation and effective reporting, which started in 2017, two workshops were held for beneficiaries of institutional grants approved in the call of August 2016 (6 and 7 April 2017 in Zadar and 24 April 2017 in Split), and one workshop each for beneficiaries of institutional grants approved in four calls published in 2017: in February (for CSOs which had not yet used the said type of support), in March (CSOs from the Homeland War which are active on the level of the Republic of Croatia), in May (CSOs from the Homeland War which are active on the county, city or municipality level) and in August (regular call for CSOs active in the area of democratisation) – of the four mentioned workshops, one was held in early July, and three in December 2017 in Zagreb, following the signing of the financing agreement.

During 2017, there were several visits to events organised by CSOs, foundations and schools – beneficiaries of different financial forms of support by the National Foundation.


— To the efficient investment from public sources

The National Foundation systematically evaluates the programme and financial part of the implementation of approved grants, with the aim of determining the efficiency of investments and level of change occurring in the local community and the society due to grant implementation, in order to be able to adjust accordingly its priorities and approval


process for grants through which it fulfils its basic purpose and mission.

In this regard, the National Foundation requests a return of the funds paid for the implementation of the approved grant if they have been spent for purposes other than what they were intended for, which means funds spent non-compliantly, i.e. for purposes other than those agreed in the specification of costs for grant implementation which is an integral part of the contract/agreement, or funds which are not entirely spent on the implementation of the approved grant.

The year 2017 also saw a decline in the amounts of unspent funds compared to the previous 3 year.

With the activities and grants approved and implemented in 2017, the National Foundation for Civil Society Development participated as the competent or co-competent authority in the implementation of the measures of the National Strategy for the Creation of an Enabling Environment for Civil Society Development, National Strategy of Equalisation of Opportunities for Persons with Disabilities, National Programme for the

Protection and Promotion of Human Rights, National Policy for the Promotion of Gender Equality, National Strategy for Social Entrepreneurship in the Republic of Croatia (in the proposal), Implementation Programme of the Development Cooperation National Strategy of the Republic of Croatia, and the Action Plan for the implementation of the National Strategy for the Inclusion of the Roma.



To preservation of the environment


- by improving its operations

In 2015, the National Foundation introduced online applications to tenders and calls, thus, in five calls published in 2017 through the platform www.financijskepodrske.hr, which is also used by other state administration bodies, a total of 386 applications were received and referred to members of evaluation bodies (five in each evaluation) in electronic form. This contributed to the preservation of the environment by not using paper documentation, since it would require cutting down trees and wasting significant amounts of water for their processing, and would pollute the environment with

a certain amount of oil. In addition, the platform www.financijskepodrske.hr enables beneficiaries of approved grants to submit reports on the implementation of approved grants in electronic form, thus contributing even further to the preservation of the environment, since in 2017 there were 401 reports received overall on grant implementation (refers only to the reports for the first quarter and semi-annual reports, while the submission of final reports for 2017 will take place at the beginning of 2018).

Support in 2017

In 2017, the National Foundation for Civil Society Development approved and ensured the continuity of implementation of 377 financial grants and activities related to democratisation and civil society development, organisational development (institutional grants), exchange of knowledge, civic actions in the community, volunteering, decentralisation, regional development, centres of knowledge for social development, development of philanthropy and non-institutional education.

There were 377 financial grants to CSOs approved from the National Foundation's funds, for the implementation of which the funding amounted to HRK 43,180,121.11. In addition, the National Foundation, in cooperation with the Ministry of Croatian Veterans, approved 24 institutional grants to CSOs from the Homeland War, the implementation of which was paid from the Ministry's funds and amounts to HRK 1,419,674.80. The Ministry of Croatian Veterans provided additional funding for the preparatory phase in the implementation of activities by 15 CSOs from the Homeland War as the Centre of Knowledge (CSOs which used institutional grants from 2014 to 2016), for which the amount of HRK 1,158,970.62 was paid.

Transparency and Criteria

Grants of the National Foundation for Civil Society Development are awarded through public tenders and calls in accordance with the annual calendar of publication of tenders, calls for expression of interest in cooperation and negotiated procedures for development cooperation published in December of the current year for the following year.

All of the tenders and calls have specified objectives to be achieved through them and complete tender documentation with the application criteria published. In addition to the tender documentation, also published is the evaluation form for the applicants to know based on which criteria all of the applications are evaluated.

The applications that meet the basic stipulated criteria of the tender or call are referred to the evaluation by independent evaluation bodies the members of which independently evaluate applications through the computer programme Potpora_Plus, which generates all the results of the evaluation and then ranks them by quality and by the score achieved.

Best quality applications are approved for grant funding and conclusion of a financing agreement, followed by monitoring of the efficiency of their implementation.







Decentralised Model of Financing

The National Foundation has been implementing the decentralised model of financing civil society development in the Republic of Croatia since 2007, through partnership with four regional foundations.

In 2017, partner foundations launched a call on 15 April 2017 for civic actions entitled "Our Contribution to the Community" and approved grants for a total of 95 civic actions in 19 counties in the Republic of Croatia.

In accordance with the Decision of the new Management Board of the National Foundation, the implementation of cooperation with four foundations in the former way ended in 2017, and will be continued through the programme cooperation in the area of providing support to CSOs and local communities, i.e. the "Active in the Community" programme, which will be implemented by four foundations on the regional level in local communities with the aim of developing social capital, the culture of giving for the common good and implementation of social programmes in local communities.

Regional Development

The aim of the regional development programme is to enhance the existing infrastructure for the harmonisation of regional development of the civil society, development of active citizenship and social capital in local communities, and preparation for the use of EU funds (European Social Fund). The Programme has continuously been conducted

since 2007, and in 2017, it was implemented in cooperation with five CSOs – regional support centres through five sub-programmes in each region. The programme still focused on providing information, consultations and training to CSOs in order to contribute to their professionalisation and efficiency.



In the framework of implementation of the "E-misija" programme in five regional self-government units, an assessment of needs was conducted and, accordingly, 28 workshops were held for 401 participants. Through 12 monthly newsletters, 2507 organisations and institutions were informed, while websites recorded 10,847 visits and 796 reactions on social networks. There were 147 individual consultations for 238 beneficiaries of the programme, while most commonly asked questions were related to the establishment and work of CSOs, management of CSO

finances and launched calls. The programme was also involved in crowdfunding campaigning, as well as in new platforms for crowdfunding ("Do the Right Thing Platform" (Platforma Čini pravu stvar)), which makes beneficiaries of the programme more motivated for new means of fundraising. A handbook was published on CSO operations (Poslovanje udruga), which covers provisions of the Associations Act, Labour Act and Civil Obligations Act, as well as regulations governing economic activity of CSOs.



During 2017, numerous informative and educational activities were held, as well as services aimed at increasing capacities of CSOs and regional communities, and at empowering beneficiaries to withdraw funds and informing them about the EU or national funding possibilities. Information on 78 different calls and notices on other important information of interest to CSOs were published on the programme's website. A part of the programme also

includes the publication of an online newsletter with 816 subscribers. Also, the programme supported an internet forum dedicated to civil society, which has more than 1,400 posts. The programme provided consulting services on a daily basis through phone calls, internet forum and personal contact. Training services were provided mostly through half-day thematic workshops which drew high attendance and interest.



During 2017, in the framework of the MRRAK programme, 23 workshops with a total duration of 30 days and 6 different topics were held for 339 participants in Brinje, Buzet, Delnice, Gospić, Karlovac, Opatija, Rijeka and Zagreb. The average (cumulative) grade assessing the achievement of the workshops' objectives was 4.68 (grading scale was from 1 to 5). Throughout the year, more than 200 different



The CSO database includes 830 CSOs from all four counties covered by the programme. There was a total of 857 hours of informing, with 539 CSOs and individuals being regularly informed on topics relevant for the development of civil society and local community through the "ŠALTER" programme's e-mailing list. The information service was used by 410 CSOs and individuals through phone calls, e-mail or by coming personally to the office. The website



In 2017, direct services (consultations, training and informing) of the "JAKO" programme were used by more than 340 beneficiaries. Every issue of the programme's e-newsletter (19 issues in total) was delivered to more than 1,900 e-mail addresses of beneficiaries. More than 550 news items from CSOs were posted on the "JAKO" programme's websites, which were viewed by about 6,000 visitors, and more than 130 news items from CSOs were posted on social networks (916 followers). More than 100 consultations (with a total duration of 178 hours) were provided. There were 192 beneficiaries involved in the

pieces of information and advice were provided to beneficiaries. In 2017, a publication on monitoring and evaluation of projects was generated, as well as audiovisual presentations on CSOs' project logic and financial plans, and a website for a quality management system for civil society organisations – "OK 2015".

For the counties: Osijek-Baranja, Vukovar-Srijem, Požega-Slavonija, Brod-Posavina

received 25,482 visits. 138 CSOs received 195 hours of consultations and support in preparation of projects and budget for applications to EU calls, volunteering, financial and administrative operation, drafting and amending the Statute and other questions of importance for organisational development. A total of 15 trainings was organised for 246 representatives of CSOs and institutions, with a total duration of 119 hours.

For the counties: Međimurje, Krapina-Zagorje, Koprivnica-Križevci, Varaždin

total of 25 organised workshops. Most of the beneficiaries use several services of the programme, and have thus achieved both personal and organisational development. Major CSOs pay more attention to long-term strategic planning, improvement of quality and impact measurement. Indirect contribution to the programme is visible in an increasing number of CSOs and their representatives who are getting involved in advocacy processes, primarily on the local level, and who cooperate with decision-makers and public policy operators.



In addition, in 2017 fifteen CSOs successfully completed the transitional period of development cooperation to become a part of the 9th Centre of Knowledge in the area of improving the quality of life of Croatian war veterans and civil victims of the Homeland War (Alliance of County Associations of Croatian Disabled Homeland War Veterans (HVIDRA), Association of Croatian Homeland War Volunteers, Association of Volunteers and War Veterans of the Croatian Homeland War, Association of Homeland War Veterans INA-NAFTAPLIN "KVIN", Union of Associations of Civil Victims of Croatian Homeland War, Association of Children of Fallen and Missing Croatian Homeland War Veterans, Association of Special Police Unit from the Croatian Homeland War, Union of Associations of Families of Imprisoned and Missing Croatian War Veterans,



Community Association of Croatian War Veterans Treated for PTSD, Association of Veterans of the 4th Guards Brigade, Croatian Reserve Officers Association, Association of Veterans of the 5th Guards Brigade "Sokolovi" (The Falcons), The "Bojna Frankopan" Association, Assembly of Associations of Croatian War Veterans' Guards Units, Association of War Veterans and War Police Veterans from the Homeland War)

— Through development cooperation with the National Foundation, the Centres of Knowledge implement:

- Research and analysis of public policies in the area of activities;
- Transfer of specific knowledge in the Republic of Croatia and in the countries of Southeast Europe;
- Development of social potential;
- Advocacy for positive social change.

The most significant activities of the Centres of Knowledge in 2017:

Environmental protection, sustainable development and use of renewable energy sources

Numerous studies, analyses and advocacy in the area of environmental protection and sustainable development resulted in one of the greatest achievements in 2017, which is removing a waste incinerator from the City of Zagreb's Spatial Plan.

Given the fact that this campaign is the oldest one in this area, it is important to emphasise tremendous long-time effort of the professional team, which contributed with its work to the requests related to such a project being approved by members of the Assembly of the City of Zagreb.

An important part of this campaign includes numerous volunteer hours which activists and volunteers have invested over the years. A number of partnerships were established with local CSOs and/or initiatives from the area designated for the construction of the incinerator. Moreover, the first anthology

of climate fiction titled "Homo Climaticum" was prepared and published under the project "School of Sustainability". It is the first such publication, both in the Republic of Croatia and beyond, and has also been translated into English, which will help it reach a wider audience.

All activities conducted in the framework of this area are covered in the media and are characterised by a great number of direct and indirect beneficiaries involved. In 2017, there were 3,030 direct and 74,978 indirect beneficiaries. Some of the conducted activities were related to the promotion of ethical consumption and promotion of transparent management of natural resources.

Civic activism and building of democratic institutions in the society

In 2017, public events, trainings and informative activities were organised which contributed to the development of civic competence of the youth and teachers, participation of citizens in policy-making processes, especially electronic and protest participation, and contributed to transparency, improvement of electoral legislation and fight against corruption. The activities were done mostly independently, but also in partnership, which contributed to the development of the existing and new networks.

Research was conducted on political and regulatory networking of powerful individuals, groups and networks which claim and/or use the system or a part of the system to achieve particular interests and gain control over public institutions, services and resources. It was published in a publication titled "Naša zarobljena mista" (Our Captured Places).

A contribution was made to the improvement of implementation of civic education in the formal system, as well as to the development of civic and social competence through informal education by developing and implementing own educational programmes, but also by supporting schools (School of Economics and Tourism Daruvar) and local communities (Rijeka) which introduced civic education. Moreover, online educational modules have been developed, which include animated films and videos independently or in cooperation with the GOOD initiative. Through the mentioned activities, an impact was achieved on transparency and involvement in the making of education public policy.

The role in informing citizens on elections, as well as in mediating between them and institutions in the case of irregularities or difficulties when it comes to exercising the electoral right, was further implemented.

Social inclusion and reduction of poverty

The impact on social development is visible in all activities involving networking of stakeholders by organising actions with the aim of providing support to vulnerable groups and affirmation of solidarity and civic activism. In the last year, systematic work on the reduction of poverty, social inclusion and destigmatisation of marginalised groups was continued by advocacy and change of legal regulations with the aim of improving the beneficiaries' status and active interventions within the framework of networks on the local, regional and international level, as well as by conducting research and analysis of public policies.

It is important to highlight the City of Split award in 2017 for successful actions in promoting solidarity in the area of reduction of poverty, providing support to the youth with behavioural issues and those who are not covered by alternative care, as well as promotion of civic activism and volunteering.

In the previous period, support was continuously provided to reception centres and shelters for the homeless in the Republic of Croatia (Varaždin, Zagreb, Karlovac, Rijeka, Pula, Zadar, Šibenik, Kaštela and Dubrovnik).



— Youth activities

Through the conference titled "How, Why and for Whom: A New Youth Strategy", organised in cooperation with the Association of Youth Information Centres in Croatia, a total of 64 people were informed on the issues relevant for developing a new National Youth Programme.

The conference was preceded by online consultations on the national youth programme, in which 198 people participated.

On the conference, the participants presented their research and activism work, written/implemented during the programme. The participants were supposed to organise a social action in the local community on the basis of the obtained research results, in order to respond to the needs observed. Some of the implemented actions include: organisation of a forum on the education of refugees; round table on volunteering, workshop on the rights of young people with malignant diseases, lectures on civic education, public discussion on the outflow of youth from Croatia etc. Apart from the presented research and activism tasks, the participants of the final conference had the op-

portunity to hear a lecture delivered by Ross and Christine VeLure Roholt from the University of Minnesota, where they are implementing the "Youth Studies" programme.

Systematic work on social networks, combined with a proactive approach to the media, produced significant results in this area as well: the number of media posts increased by 13% in relation to 2016, in which a significant increase of 300% had been observed in relation to 2015.

The second and third modules of the programme were held within the informal educational programme "Youth Studies": the second module titled "Contribution of the Youth to the Protection of Human Rights through Activism and Social Change Yesterday and Today", which was aimed at raising awareness on social changes and movements, with a focus on those which had been brought about by young people, and the third module titled "Youth Policies", under which the participants were informed on youth policies, with a focus on employment and educational policies.

—Independent culture

The 17th continuous programme exchange and cooperation cycle was successfully implemented within the programme "Clubture-Hr: Program Exchange and Cooperation". There were 39 CSOs involved in the implementation of the programme and more than 80 individual cultural and art events were organised in 25 towns and locations in Croatia, involving more than 4000 citizens, most of which were young people. More than 70% of all activities were organised outside the capital.

Moreover, the 10th independent cultural organisations meeting, i.e. the 10th Clubture Forum, was organised in Rijeka. More than 50 CSO representatives thus shared their knowledge and gained new insights into networking and cooperation development. Representatives of a wider range of organisations from different parts of Croatia acquired new information on the implementation and possibilities of involvement in the "Rijeka 2020 – Cultural Capital of Europe" programme. Also, a rich and diverse cultural and art programme was presented, which was prepared by the CSOs which are members of the network, and independent cultural

organisations in Rijeka. Furthermore, a debate was opened on cultural and social development of Rijeka and Croatia, as well as the impact of the Cultural Capital of Europe's projects, with the involvement of citizens, CSO representatives, decision-makers' representatives and cultural workers on the local level.

Work on enhancing the visibility of network and independent cultural scene was continued through the development of an interactive archive map of projects implemented within the programme "Clubture-Hr: Program Exchange and Cooperation" and through a tour of an exhibition titled "Independent Spaces", which visited Zagreb and Rijeka in 2017.

A study trip was organised with the aim of research and comparative analysis of the framework of policies under which CSOs in Poland operate. The network is systematically involved in monitoring development and implementation of public policies in the areas of its activity, through direct advocacy and public consultations, but also through the work of the Council for Civil Society Development.

Sustainable living and development of permaculture

In 2017, there were numerous trainings and practical workshops held in the Republic of Croatia and in the international community, and the areas are gradually expanding and networking.

One such example are workshops of biotecture, i.e. vertical green gardens suitable for urban spaces, which are a combination of the construction, food and energy sectors.

Currently, there is a new facility under construction of the so-called bioshelter at the Recycled Estate, which is a unique example of smart and efficient design for food production. It is also important to mention participation in the work of the International Panel of Experts on Sustainable Food Systems IPES-FOOD, working on the development of a strategy in this area for the EU until 2020. Cooperation with schools and other educational institutions even with no significant official project supporting it, is constantly being developed and supported. Good economy has become a widely accepted term

today, and it is used by a whole range of other organisations. In 2017, there were 63 activities and events implemented in the Republic of Croatia, and through international cooperation, 252 free consultations provided for citizens by the Institute for Permaculture.

The greatest achievement of the organisation is the capacity of parallel continuous construction of the Recycled Estate and creation of cooperation with numerous partners and activities outside of the Estate itself, which significantly contributes to social change.

— Protection and promotion of human rights

The year 2017 saw further development of programme activities with the aim of establishing a free, open, pluralistic, democratic, equal and inclusive society based on respect, protection and promotion of the highest standards and norms of human rights and freedoms. Through the implementation of research and monitoring activities, the National Foundation aims to persist in the establishment of a Centre of Knowledge which possesses relevant data and insights on issues within specific human rights sectors.

Accordingly, the work in the area of public policy research became more intensive in 2017, primarily through the improvement of the quality of research activities through modernisation of the methodology and the research process itself for the purpose of drafting the annual report on the human rights situation. Particular emphasis was also placed on the implementation of focused thematic research in the areas of human rights in which there are no relevant cognitive data and overview of the situation, such as research on the access to free legal aid, research on non-liberal democracies, research on the freedom of assembly, and monitoring of activities.

In 2017, a permanent partnership was established with academic institutions through research and monitoring activities with the aim of mutual exchange of the latest cognitive insights and experiences gathered from practice, as well as further networking and expanding of partnership to sectoral CSOs. In the area of training, diversification was achieved with regard to the training programme with the aim of developing and adapting educational curricula for the training of different target groups, such as students, high school students, volunteers and activists. In the previous period, the activity of monitoring the membership of the Republic of Croatia in the United Nations Human Rights Council, but also new memberships in networks such as Civic Solidarity Platform and Legal Experts Advisory Panel, was increased. Apart from that, the cooperation in already existing CSO networks, such as Human Rights House Network and Platform 112, was intensified. Moreover, advocacy activities were strengthened with the aim of speeding up the process of ratification of the International Convention for the Protection of All Persons from Enforced Disappearance and European Social Charter (revised).

— Improvement of the quality of life of persons with disabilities

In 2017, the Centre of Knowledge in the area of improvement of the quality of life of persons with disabilities, consisting of thirteen unions of CSOs of persons with disabilities, continued to work systematically on the promotion of human rights of persons with disabilities guaranteed by the UN Convention on the Rights of Persons with Disabilities. Advocacy intensified in 2017 in view of the protection of women with disabilities, while the activities focused on stronger action in relation to fostering the improvement of policies for persons with disabilities and their families, as well as the surveillance and monitoring of the National Strategy for Equalisation of Opportunities for

Persons with Disabilities 2017-2020.

In 2017, a total of 140 employees actively participated and thus gave their contribution to numerous activities implemented within the Centre of Knowledge in the area of improvement of the quality of life of persons with disabilities. There were 402 volunteers involved in the programmes with 15,383 volunteer hours. A total of 85,382 direct beneficiaries were involved in the implementation of different activities, and the unions had 879 posts in the media in the previous period.

Improvement of the quality of life of Croatian veterans and civil victims of the Homeland War

In the beginning of 2017, the Ministry of Croatian Veterans and the National Foundation signed the Agreement on Development Cooperation through programme grants in the implementation of systematic support to CSOs from the Homeland War in the Republic of Croatia. Thus, in the previous period after 2014, 15 CSOs from the Homeland War which commenced the preparatory phase for entering the

Centre of Knowledge for Social Development in the area of the improvement of the quality of life of Croatian veterans and civil victims of the Homeland War by signing this agreement became beneficiaries of a three-year institutional grant for stabilisation and/or development of CSOs within the framework of systematic types of support by the National Foundation for Civil Society Development.

Institutional Grants – Investment into CSO Development

Institutional grants represent a specific part of the National Foundation's grants programme through which in a targeted manner, for a three-year period, investments are made into the organisational development or stabilisation of CSOs registered in the Republic of Croatia, with the aim of raising the level of sustainability of CSOs contributing to democratisation and civil society development in the Republic of Croatia.

The year 2017 saw continued financing of institutional grants approved in the calls of 2014 and 2015 (third and second year of implementation), and financing and implementation of institutional grants approved in the call launched in August 2016 (first year of implementation) commenced. Furthermore, financing and implementation of institutional grants approved in the call launched in February started – for CSOs which had not used the mentioned type of the National Foundation's grants, and for the first time a separate call was launched for them,

while institutional grants, whose implementation will start in 2018, were contracted at the call launched in August for CSOs operating in the area of democratisation and social development.

Under the Agreement on Development Cooperation through programme grants in the implementation of systematic support to CSOs from the Homeland War, concluded with the Ministry of Croatian Veterans, the National Foundation launched calls for grants to CSOs from the Homeland War – in March for CSOs from the Homeland War active on the level of the Republic of Croatia, and in May for CSOs from the Homeland War active on the county, city or municipality level, which was financed by the Ministry of Croatian Veterans, while the whole tender procedure and monitoring of approved grants falls within the competence of the National Foundation.

Non-Institutional Education

In May 2017, the National Foundation launched a call for grants to CSO projects in the area of non-institutional education of children and youth in the school year 2017-2018, in accordance with the Agreement on Development Cooperation which was concluded between the National Foundation and the Ministry of Science and Education. In total, 35 grants were approved in 3 sub-categories of the call:

The implementation of approved projects, carried out by CSOs in partnership with one educational institution (primary or secondary school), started on 1 October 2017 and should be completed by 31 August 2018 at the latest.

The implementation of approved grants will contribute to expanding opportunities for children and youth to acquire knowledge and skills, as well as to establish adequate attitudes and improve the quality of life, according to their interests and abilities, but outside the regular education system; to increasing knowledge of children and youth regarding human rights and active citizenship; to sensitising

children and youth on the values of volunteering and their involvement in volunteering actions in the local community and/or school; to promoting peace and non-violent conflict resolution among children and youth; to promoting healthy lifestyles, preservation of nature and sustainable development among children and youth; to inclusion of children and young people with special educational needs (gifted pupils and pupils with difficulties) and to improving the quality of life for children and youth in local communities with fewer opportunities (local communities with a development index of less than 75% of the development index in the Republic of Croatia).

Knowledge without Borders

The call for expression of interest titled "Knowledge without Borders" has the objective of providing support to the participation of Croatian CSO representatives in international conferences, as well as the participation of international experts in conferences organised by CSOs in the Republic of Croatia for the purpose of encouraging the acquisition and exchange of knowledge, skills and experiences needed for active and entrepreneurial activities in the community and society. In addition, CSOs active on the international level had the opportunity of co-financing travel to meetings of international organisations/institutions whose members they are, and thus to represent and present the Republic of Croatia.

In 2017, the National Foundation for Civil Society Development approved a total of three grants to CSOs active in the area of children and youth, education and protection of hu-

man rights through this call in all of its three versions. The relatively small overall number of applications (7), as well as of approved grants, is due to the rule which states that grants to CSOs for participation in an international conference, for arrival of an international expert to an event in Croatia or for participation of a CSO representative in the work of management or advisory bodies of international organisations/institutions cannot be approved if these CSOs are, at the moment of application, beneficiaries of any type of grant given by the National Foundation from the national sources (institutional grants, partnerships, development cooperation). In such a way, the largest number of similar needs is regulated through these previously approved grants, while the call for the expression of interest "Knowledge without Borders" was available to those CSOs which were not beneficiaries of the mentioned grants.

"Heart Print" Award In 2017 - VOLUNTEERING

Volunteering is one of the fundamental values of civil society, and the engagement of children and youth in volunteering initiatives and actions is a precondition for the development of civic activism and civic education of children and youth.

In 2017, the National Foundation launched a call for volunteering initiatives and innovative models of volunteering development, and awarded the best applications with the "Heart Print" award under the motto:

You don't have to walk on water or be better than others you have nothing more than anyone else does, but what makes a difference are acts which leave in others your mark... a heart print..."



With this award, the National Foundation strives to encourage and award primary and secondary school students, their volunteering initiatives and engagements testifying to their selfless desire to contribute to their local community through their activities, in order to make their own life and the lives of others in it more pleasant and fulfilled.

The annual "Heart Print" award ceremony was held on 1 December 2017 in the National and University Library in Zagreb for 10 volunteering initiatives of primary schools, as well as for 5 innovative models of volunteering development in secondary schools. The award ceremony was attended by students from 5 schools from Zadar, who made their contribution to the Philanthropy Week 2017 and were given the award under the motto "Kindness brings and binds us together".

Cross-Sector and International Cooperation

Since 2006, the National Foundation for Civil Society Development has implemented cross-sector cooperation programmes in the facilities of former military barracks in Zadar, which were renovated into the IMPACT – European Centre for Cross-Sector Partnerships.

IMPACT - European Centre for Cross-Sector Partnerships implements its activities with the support of a wide range of partner organisations, trainers, mentors and experts from Croatia, Southeast Europe and other countries.

On 2 September 2017, the Management Board of the National Foundation adopted a decision on turning IMPACT into an institution for adult education in the area of civil society development and EU funds management.

Number of organised events

In 2017, IMPACT — European Centre for Cross-Sector Partnerships organised various seminars, workshops, conferences, round tables, summer schools, public forums, annual assemblies and meetings on the topic of cross-sector cooperation and EU funds, in cooperation with the public, business and non-profit sector.

Number of events held at the IMPACT centre:

81 (of which: seminars/conferences/lectures: 46 and round tables/workshops/presentations/meetings: 35)

With the aim of informing and exchanging knowledge and experiences, the following study visits were organised by the National Foundation:

- In May 2017, about 20 students of the Faculty of Law (Social Work Study Centre) from Zagreb visited the National Foundation in order to familiarise themselves with the work of the National Foundation within the framework of the established support system to CSOs in the Republic of Croatia;
- In December 2017, 8 members of a delegation from the Kyrgyz Republic (representatives of the Ministry of Health and NGOs) and 4 representatives of the JSI Research Training Institute and Health Policy Plus project Palladium Group from the U.S. visited the National Foundation to present possibilities of financing CSOs.

Cooperation in the Euro-Mediterranean

Since 2009, the National Foundation for Civil Society Development has acted as the coordinator of the Croatian network for cooperation in the Euro-Mediterranean, as a constituent part of the international network of the Anna Lindh Euro-Mediterranean Foundation for the Dialogue between Cultures (ALF). The Anna Lindh Foundation covers 42 countries as a form of multilateral partnership within the framework of the Union for the Mediterranean, which is institutionally linked to the Euro-Mediterranean Partnership, better known as the Barcelona Process. In this role, the National Foundation represents the national network, providing the membership and the broader public with the information about the activities and tenders of ALF, facilitating search for project partners and project application procedure, ensuring promotional activities, organising coordination meetings for the Croatian Network members, maintaining continuous communication with the ALF Secretariat and contributing to the development of annual and triennial ALF programmes.

In 2017, the Croatian Network's membership continued to grow, thus, by the end of the year, it consisted of 151 members, which makes it one of the largest national networks within the ALF.

The annual meeting of the Croatian Network was held on 6 and 7 September 2017 at IMPACT — European Centre for Cross-Sector Cooperation in Zadar. As part of presenting the work of organisations-members of the Croatian Network, preliminary results were presented of the "Art of Democracy in Euro-Med Region" project, which was implemented by the "Petit Philosophy" Association for Promotion of Informal Education, Critical Thinking and Philosophy in Practice, which was awarded grants at the ALF's call at the end of 2016, and which was also co-financed by the National Foundation in accordance with the Ordinance on the Conditions and Criteria for Co-Financing Projects and Programmes Approved within the "Cooperation in the Euro-Mediterranean" Programme.

By the end of 2009, the National Foundation established a programme for co-financing projects approved within

the "Cooperation in the Euro-Mediterranean" programme. Through its short-term and long-term projects and programmes which were approved at the ALF call, the National Foundation had the opportunity to offer grants amounting to up to 20% of the total value of the approved development initiative/project.

At the annual Croatian Network meeting, Tamara Krupski, the new coordinator for the Union for the Mediterranean at the Ministry of Foreign and European Affairs, and Filip Vučak, Croatian ambassador to Paris, introduced themselves to all participants. Moreover, Drago Župarić-Iljić from the Institute for Migration and Ethnic Studies (member of the Croatian Network) delivered a lecture on the current migration trends and accompanying social changes in the area of the Euro-Mediterranean, as well as on their impact on intercultural exchange in the Euro-Mediterranean region. The meeting also provided room for a discussion on possible activities of the Croatian Network for cooperation in the Euro-Mediterranean in the following period, in relation to the announced action plan of the ALF and future types of AFL activities.

The regular annual meeting of the AFL national coordinators took place from 12 to 15 December 2017 in Tallinn, Estonia. It focused on strategic thinking for the following operating period of the ALF as the main network for dialogue between cultures in the Euro-Mediterranean region, in which the Croatian Network for the Cooperation in the Euro-Mediterranean actively took part.

The ALF includes 42 countries as a form of multilateral partnership within the framework of the Union for the Mediterranean, which is institutionally linked to the Euro-Mediterranean Partnership, better known as the Barcelona Process.

Development Cooperation

Philanthropy and foundations

In 2017, the National Foundation continued to support the development of philanthropy and foundations through the work of the Croatian Foundations Forum ZaDobroBIT!, and additionally through the establishment of development cooperation with the European Foundation for Philanthropy and Social Development, given that the development of foundations in the Republic of Croatia is lagging behind that in other EU Member States.

The said cooperation encourages further development of philanthropy and foundations, increases recognisability of foundations in the Republic of Croatia, and raises the quality of their activities and the culture of giving for the common good, promoting social innovations in local communities, with cooperation also achieved with the European Foundation Centre in the use of the European Philanthropy House in Brussels, and implementation of a campaign on philanthropy and establishment of the Croatian Philanthropy Centre (which moved from Rijeka to the IMPACT Centre in Zadar). The Croatian Foundations Forum "ZaDobro.BIT" gathers 30 foundations registered in the Republic of Croatia in various areas of activity. In April 2017, the 7th annual meeting took place in Zadar, while the Forum's member CSOs gathered once again in October at the Conference on Philanthropy and Foundations, which was organised as part of the Philanthropy Week 2017.

Philanthropy Week 2017

In 2017, the Republic of Croatia participated for the second time in the celebration of the European Day of Foundations and Donors, celebrated on 1 October across Europe. Thus, the Philanthropy Week 2017 was organised from 25 September to 2 October 2017 in major Croatian cities.

The National Foundation, in cooperation with the European Foundation for Philanthropy and Social Development and foundations participating in the Croatian Foundations Forum "ZaDobroBIT", supported the activities during the Philanthropy Week, with the main event held from 30 September to 2 October 2017 in Zadar.

A commemorative exhibition was organised at the People's Square in Zadar, demonstrating the development of philanthropy in the Republic of Croatia over time, while foundations participating in the Croatian Foundations Forum "ZaDobro. BIT" were presented to the citizens. In agreement with schools from the City of Zadar and Zadar County, primary and secondary school students also participated in the event held in Za-

dar, expressing their philanthropic contribution through messages of kindness which they bound together in their paper "chains of kindness".

In addition, the Philanthropy Week initiated a joint action among the schools which were involved, with the aim of taking action in the local community. Namely, four primary schools and one secondary school worked together and proposed a praiseworthy action titled "Designing a Children's Picture Book with Philanthropic Theme", given that they had observed the need to encourage students and their parents to think about philanthropy and ways in which they could participate in helping people in need.

Through the initiated action, the schools were awarded by the co-organiser, European Foundation for Philanthropy and Social Development, with the amount of HRK 2,000.00 each. Hardworking students and teachers belong to the following awarded schools:

Furthermore, together with the European Foundation for Philanthropy and Social Development, the National Foundation organised a Conference on Philanthropy and Foundations. The conference was held on 2 October 2017 in IMPACT – European Centre for Cross-Sector Cooperation in Zadar, and was attended by both local and international philanthropy experts.







Visibility and Information

The National Foundation's official website (http://zaklada.civilnodrustvo.hr) is a means of informing the general and interested public on the work of the National Foundation, tenders and calls for expression of interest, results of tenders, announcements of seminars and training programmes of partner organisations, consultations, information on the decisions of the Management Board, reports from conferences and multi-media features, and direct online broadcasts of consultations and meetings organised for the needs of the interested public.

During 2017, the website had a further increase in the number of visits in comparison with the previous year, reaching a monthly average of 57,082 hits.

Furthermore, in 2017 the National Foundation proceeded with its multi-annual continuity of providing information on the activities of CSOs in the European Union, and on the announcements of calls from the European Social Fund.

In addition providing information on its website, the National Foundation also informs the interested public through emailing lists, newsletters, almanacs, and by providing professional and technical support to the civilnodrustvo.hr portal.

Civilnodrustvo.hr Portal

In 2017, the civilnodrustvo.hr portal continued to present in one place the richness, diversity, power and abundance of CSOs, activities of civil society activists and work of CSOs.

The portal is a place which connects CSOs and consolidates information from a wide spectrum of actions, activities and thoughts of the stakeholders of civic activism and creators of civic initiatives, which were reported in the announcements of events, actions, protests, interviews and columns.

In 2017, the Civil Society portal (www.civilnodrustvo.hr) published once a month the e-newsletter "Civil Society - EU Projects".

In its 12 issues, the newsletter published on its four pages almost 200 reviews, announcements, reports from events organised within the framework of projects co-financed from the European Social Fund. All newsletters were also disseminated via social networks Facebook and Twitter and had a significant number of individual downloads.





Potpora_Plus, elzvještavanje (eReporting)

The National Foundation also achieves efficiency of its activities by continuous investments into computer systems, support and training, both of target programme users and of its own employees.

The National Foundation continued to upgrade the Potpora_plus programme as a unique computer system for monitoring financial grants, which is used by 16 state administration bodies which have established some kind of grant giving for CSO projects and programmes. In 2017, the module for assessment of applications according to the requirements of published calls financed from the European Social Fund was adapted in order to increase the efficiency of that segment of the procedure.

In cooperation with and for the purposes of the Croatian

Government's Office for Cooperation with NGOs, the National Foundation continued to develop the elzvještavanje module in 2017, as a website which serves as a single point to publish annual reports by levels for all institutions/state administration bodies/local and regional self-government units/companies with full or majority ownership by the Republic of Croatia, which finance CSOs from public sources, and serves to the Office for Cooperation with NGOs as an efficient data retrieval service and for reporting on the financing of CSOs in the Republic of Croatia by the year of financing.

In order to increase the efficiency of monitoring the implementation of projects financed from the European Social Fund, the National Foundation has developed a platform for reporting called ESF_Plus, which enables digitalisation of the procedure for reviewing requests for payment.



Financijskepodrske.hr

The website www.financijskepodrške.hr, developed by the National Foundation, is a platform which enables CSOs to send e-applications to launched calls.

Financijskepodrske.hr is the only platform launched in order to connect in one place the grant givers and grant receivers at all stages of grant giving and implementation of approved grants. In this way, all information related to the publication of calls, applications, results of the calls, and grant implementation is integrated.

As a platform, financijskepodrske.hr not only provides administrative simplifications, but has also reduced large amounts of paper which were used in previous regular applications for the calls. This is an advantage both for the applicants

and for the beneficiaries of Potpore_Plus, another National Foundation's online service used by those giving grants to CSOs, and which is directly connected with the use of the application system Financijskepodrske.hr.

In 2017, beneficiaries of the approved grants submitted their semi-annual reports and final descriptive and financial reports on the implementation of the approved grants together with the pertaining attachments which documented the implemented activities and indicated expenses through the platform www.financijskepodrske.hr. Furthermore, online applications were also successfully implemented for all calls launched by the Ministry of Demographics, Family, Youth and Social Policy.

ESI Funds

On 16 August 2012, the National Foundation for Civil Society Development received the Decision on Accreditation as Intermediate Body Level 2 by the European Commission, for Measure 2 of Priority 5 – Strengthening of the Role of Civil Society Organisations for Socio-Economic Growth and Democratic Development. From accreditation within the IPA IV component to now, the National Foundation has participated as intermediate body in the implementation of the Operational Programme Human Resources Development 2007-2013 for the Priority Axis 5 – interventions in the field of civil society and in the Management and Control System for the implementation of the Operational Programme Efficient Human Resources 2014-2020 within the priority axes Social Inclusion and Good Governance.

As Intermediate Body Level 2, the National Foundation contributed to the preparation of the call for the submission of project proposals, administrative review of received applications to the calls, cooperation with Intermediate Body Level 1 in the selection of projects, monitoring of implementation and progress of projects, on-the-spot checks, and checks of

the use of visibility elements in all activities of the projects financed from the European Social Fund.

In order to help all interested applicants to obtain systematic support in the calls which will be launched within the framework of the European Social Fund, the National Foundation has established the Department for Support and Monitoring of EU Programmes which will operate in Zagreb and three subsidiaries: Osijek, Rijeka and Split.

The Department was established with the aim of providing systematic support to the National Foundation's activities as Intermediate Body Level 2, including: organisation of training on EU calls and programmes for interested applicants, enquiring with beneficiaries about any issues with application to calls, development of a handbook on how to avoid the most common mistakes in the preparation of project proposals, development of a handbook with the aim of supporting reviewers of project proposals, training and support to grant beneficiaries in project implementation.

Monitoring of the Implementation of Social Entrepreneurship Projects

In 2017, the National Foundation monitored the implementation of 18 projects approved under the "Promoting Social Entrepreneurship" call. The mentioned call was a kind of a step forward in financing activities, given that this group of activities had never been financed within the framework of the European Social Fund. The total value of 18 contracted projects, aimed at promoting social entrepreneurship and promoting and providing capacities of current and future social entrepreneurs amounts to HRK 10,436,767.81.

Ten grant beneficiaries, who already work as social entrepreneurs by organising a number of informative and educational activities, networking stakeholders, and supporting and strengthening current activities, will try to improve the status of social entrepreneurship with regard to its visibility, recognisability and long-term sustainability of results. Out of 18 grant beneficiaries, eight of them will become social entrepreneurs, which means that by the end of the implementation of projects (31 May 2018), 8 new social enterprises will be established.

According to indicators of the results of implementation of these 18 projects, the total number of beneficiaries in 17 counties and the City of Zagreb is approximately 3,500, while the beneficiaries and target group for which the projects are intended include the unemployed, vulnerable groups at a disadvantage on the labour market, Croatian Veterans from the Homeland War, youth, women, members of the Roma national minority and employees in social enterprises.

Implementation Workshops for Grant Beneficiaries

After entering into the grant contract, the National Foundation for Civil Society Development held implementation workshops for all grant beneficiaries with whom it had concluded a contract within the framework of the call for proposals for Promoting Social Entrepreneurship and of the call Support to the Volunteering Organisers for the Improvement of Volunteer Management and the Implementation of Volunteering Programmes.

- The workshops were held in Zagreb, and in the first workshop related to the Call for Promoting Social Entrepreneurship, there were
- 46 representatives of beneficiaries
- 18 CSOs which received a grant.
- Implementation workshops related to the Call for Support to the Volunteering Organisers held in Zagreb in front of
- 92 representatives of grant beneficiaries from
- 38 CSOs which received a grant.

The aim of implementation workshops was to familiarise all representatives of grant beneficiaries with the obligations related to the implementation of the grant contract, timely planning of activities and obligations of reporting on financed activities.

Informative Workshops for Applicants

In 2017, the National Foundation for Civil Society Development participated in the implementation of informative workshops related to the calls launched in 2017 for grants from the European Social Fund.

Thus, in cooperation with the Croatian Government's Office for Cooperation with NGOs, an informative workshop was held in Zagreb for about 90 interested applicants to the call "Support to the Development of Partnerships of CSOs and Higher Education Institutions for the Implementation of Socially Useful Learning Programmes".

In cooperation with the Ministry of Demographics, Family, Youth and Social Policy, informative workshops were held in Osijek, Split, Zagreb, related to the call "Support to Programmes Targeting Youth".

In cooperation with the Ministry of Culture, the National Foundation participated in the implementation of informative workshops in Osijek, Rijeka, Split and Zagreb, which were related to the calls "Art and Culture for Youth" and "Art and Culture 54+". The workshops were held in front of more than 300 interested applicants.

Improvement of the Procedure

In order to facilitate communication with grant beneficiaries on projects approved in the programme period 2014-2020, the National Foundation designed the reporting platform "ESF_Plus" which speeds up the process of submitting requests for payment, as well as their review and approval by the National Foundation. The platform represents a step forward in communicating with beneficiaries until a different solution is found at the level of the whole system for the management and control of EU funds utilisation.

All of the mentioned calls included 251 organisations, local and regional self-government units, private enterprises and state administration bodies, of which 63 grant beneficiaries and 188 partner organisations. The most represented county was the City of Zagreb with a total of 45 beneficiaries and/or partner organisations, and the least represented counties were Varaždin (1 partner organisation) and Lika-Senj (1 partner organisation) counties.

EEA and Norway Grants Financial Mechanisms

The implementation of the Programme for CSOs in the Republic of Croatia continued in 2017 within the framework of the European Economic Area (EEA) and Norway grants. All contracted projects were successfully completed in 2017, and thus ended the implementation of the Programme for the financial period 2009-2014.

In June 2017, the National Foundation organised a study trip for four representatives from four CSOs which received grants within the framework of the EEA and Norway grants. During the study trip in Oslo, CSOs presented the results of financed projects and participated in a conference organised by the Norwegian Ministry of Foreign Affairs, related to further financing in the subsequent period. In addition, a meeting was organised with representatives of Norwegian CSOs and pre-requisites for future cooperation were fulfilled.

As the body implementing the Programme for CSOs of the EEA and Norway grants, the National Foundation for Civil Society Development organised the final event/conference related to the end of the Programme implementation, which was held on 25 September 2017 in the Mimara Museum in Zagreb.

The conference was attended by H.E. Mrs. Astrid Versto, Ambassador of the Kingdom of Norway to the Republic of Croa-

tia, Mr. Marko Pavić, Minister of Labour and Pension System, and Mr. Velimir Žunac, State Secretary of the Ministry of Rregional Development and EU Funds. All speakers highlighted the importance of CSOs and continuity of financing in the subsequent period of EEA and Norway Grants.
